

# **Boulders Divine 9s Golf Association Bylaws**

## **Article 1**

The name of the organization is “Boulders Divine 9 Golf Association”.

## **Article 2**

The purpose of this Association is to promote growth and encourage good fellowship and camaraderie while enjoying the game of golf.

## **Article 3: Membership**

Any woman who has a golf or social membership and is in good standing at The Boulders Club is eligible for membership in the Boulders Divine 9 Golf Association. Such member having dues paid on or by Opening Day shall be entitled to vote at all general meetings of the Association.

## **Article 4: Elected Officers**

The elected officers shall consist of: President, Vice President, Secretary and Treasurer. These officers constitute our Executive Board.

### **Section 1**

President – shall prepare an agenda and preside at all board meetings and membership meetings, and appoint all committees. Prior to taking office she shall meet with the outgoing President and Treasurer and the incoming Treasurer in the preparation of the yearly budget.

### **Section 2**

Vice President – shall assist the President and perform the duties of the President in her absence.

### **Section 3**

Secretary – shall record the minutes of all board and membership meetings.

### **Section 4**

Treasurer — shall be the custodian of all funds. She shall disburse funds in accordance with the budget: sign all checks, give a report of the group’s finances at all regular meetings, and prepare and submit a yearly budget.

She shall present her books at the end of the year to the President and Vice President.

## **Article 5: Elections**

### **Section 1**

All officers shall be elected for a one (1) year term and will be eligible for a second one (1) year term of the same office. Elections shall be held at the spring general meeting and elected officers shall take their respective office in May of the current year.

### **Section 2**

All books and group properties kept by the officers shall be delivered to the successors at the completion of the final spring meeting.

### **Section 3**

The four (4) board members shall select a committee of four (4) to select a slate of officers for the next term, the consent of nominees previously obtained. The nominating committee shall consist of the current President, the Vice President, and two (2) members at large.

## **Article 6: Amendments**

Amendments to the bylaws may be passed by a majority vote of those present at a general meeting of the Association, providing the amendment was read at a previous meeting, posted in view or mailed to all members prior to the vote.

## **Article 7: Interpretations**

These bylaws shall be interpreted by the Executive Board. No changes shall be made to the bylaws except with approval of the board. Questions of procedure not covered by the bylaws shall be governed by Roberts Rules of Order.

## **Article 8: Governance**

Divine 9s is an association under the umbrella of the Boulders Members Association. Divine 9s will be governed by the policies and procedures outlined in the Divine 9s by-laws and/or those that have been documented by prior administrations per the Association's meeting minutes.
