News from the BMAC meeting on April 4th

John Wright shared the following updates from Club management:

- Resort revenue was a bit light in March, but bookings indicate April and May should be strong months for the resort.
- Memberships currently number 399 Golf, 75 Social, and 86 Clubhouse.
- The outside grounds team is almost done clearing desert broom from the South Course and will then will attack the North Course.
- After completing the desert broom project, the team plans to begin removing mistletoe, in conjunction with contractors as necessary.
- Replacement of the main practice putting green and leveling the member's practice tee area are planned during May.
- Court 3 of the tennis courts will be replaced the week of April 15th. The company doing the work will be using some of the parking spaces next to the courts.

The new Club policy prohibiting non-golf activities on the golf courses was discussed. Both management and BMAC remind members – please do not engage with anyone you find to be in violation of the policy - please let management deal with enforcement of the policy.
